L-3 Mission Integration Delivers Final Project Liberty Aircraft

GREENVILLE, Texas, September 13, 2010 – L-3 Mission Integration announced today that it has delivered the final Project Liberty MC-12W to the U.S. Air Force. This delivery marks the completion of the Liberty Project Aircraft contract effort initiated by the U.S. Secretary of Defense in response to an urgent warfighter requirement.

The airplane took off at 10:30 a.m. on Aug. 31 from L-3 Mission Integration's facility in Greenville, Texas, and flew to Key Field Air National Guard Base in Meridian, Miss. There, it will support MC-12 training of aircrew and operators deploying to Operation New Dawn and Operation Enduring Freedom. L-3 Mission Integration delivered all 37 ISR-equipped aircraft in less than 24 months; each was delivered on or before its contracted delivery date.

"The Air Force and L-3 completed an amazing feat," said Mark Von Schwarz, president of L-3 Mission Integration. "These very capable platforms went from initial contract to combat in less than eight months. This was a complex effort that not only involved rapid engineering design, but required Mission Integration to leverage its manufacturing and installation processes to successfully coordinate over 340 different contractors and multiple integration facilities. Today, Liberty is fully deployed and providing life-saving ISR support to our combat forces with a mission-ready rate of more than 93 percent."

"The people are what made this effort work," said Bob Spivey, L-3 Mission Integration vice president of special programs. "Plus, the last aircraft was delivered in 144 days – 20 percent faster in modification and test time than the first plane. L-3 Mission Integration's engineers and aircraft technicians continued to improve efficiencies and processes to get the mission-ready aircraft to the warfighter quickly."

The program received accolades from both Air Force and Department of Defense senior officials, won Laureate Award honors from *Aviation Week & Space Technology*, and was selected as the Air Force's nominee for the National Aeronautic Association's Collier Trophy.
